## GROOMING RELEASE FORM

**PAW-PARAZZI** has my permission to do whatever it feels is appropriate for the well-being of my dog. Should **PAW-PARAZZI** determine, at its sole discretion, that veterinary care is warranted, I agree to pay all associated fees and costs. If my dog's veterinarian is not readily accessible, **PAW-PARAZZI** is authorised to use a veterinarian of its choice. **PAW-PARAZZI** will not be responsible for any conditions or problems discovered during grooming.

**PAW-PARAZZI** will not be held responsible for clipper burn, minor nicks, or skin irritation resulting from grooming; nor will I be held responsible for stressful effects that grooming may have upon a geriatric dog.

**PAW-PARAZZI** shall not be liable for any after-grooming effects of de-matting clipping or brushing procedures or problems uncovered on a badly matted or otherwise neglected coat including, but not limited to itchiness, skin redness or self-inflicted irritations/abrasions from excessive external rubbing or scratching. I understand that time and costs associated with de-matting are unpredictable and subject to the particular condition of my dog; consequently, I agree to pay whatever fees are incurred as a result of de-matting. Whether a dog is "matted", furthermore, is at the sole determination of **PAW-PARAZZI**.

I agree to pay all costs for the grooming of the dog including, but not limited to, special handling requirements, de-matting, and fees due for late drop-off, pick-up or missed appointments.

**PAW-PARAZZI** reserves the right to discontinue or refuse to groom a dog that presents an unsafe condition. Such conditions include, but are not limited to behaviour issues, health problems, fleas or parasites.

I agree to inform **PAW-PARAZZI** prior to grooming if the dog has ever bitten any human or another dog or have any aggressive tendencies whatsoever. I understand and agree that I will be held solely liable for any harm, injury, or property damage caused by my dog.

I understand that missed appointments might incur a fee of up to 50% of the estimated grooming charge.

I agree to be ON TIME or up to 15 minutes early for my appointment. If I am over 15-20 minutes late, I understand that I may be required to re-book (missed appointment fees may apply).

I agree to pick my dog up within half an hour of receiving a sms or message to collect my dog. I further agree that I might be charged a late pick-up fee.

Should I have to cancel my dog's appointment, I agree to notify **PAW-PARAZZI** no sooner than 24 hours prior to the scheduled appointment.

I agree to make sure my dog has relieved itself prior to drop-off.

I agree to deliver my dog on a leash or in a pet travel cage.

I affirm that my dog's annual vaccinations are up to date and that I am the legal owner of the dog for which services are rendered.

I have read, understand, and agree to the policies of **PAW-PARAZZI** as set forth in this form.
